Legal Issues- Helpful Tips

Personal Injury- *If possible, make sure you are in a safe position away from further harm. Call 911 to report the accident immediately. Take pictures of the scene and license plate numbers, names, phone numbers, and any other helpful information. Make sure to get the insurance information of the other party. Follow any instructions the police may give you. Get names and departments of any responding police officers. Call Latoison Law.

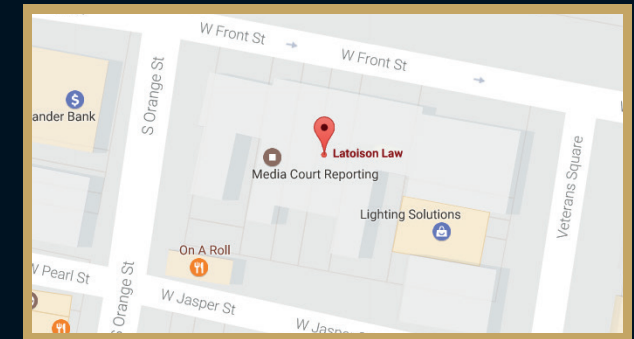

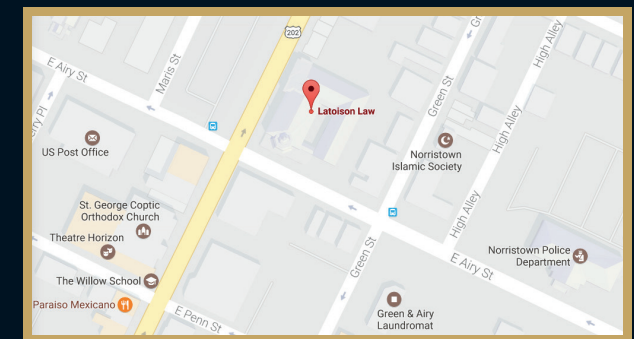
